## Sephora #BeautyTogether Twitter Sweepstakes Official Rules

- 5. <u>Sweepstakes Period</u>: The Sweepstakes begins on September 14, 2015 at 9:00 a.m. Pacific Daylight Time ("PDT") and ends on September 20, 2015 at 9:00 p.m. PDT. Entries must be received by 9:00 p.m. PDT on September 20, 2015.
- 6. <u>Selection of Winner</u>: The potential winners will be selected from all eligible entries received during the Sweepstakes Period in a random drawing conducted by Sponsor on September 21 or 22, 2015. The potential winner will be contacted by Sponsor via a direct message to the potential winner's Twitter account, and for that reason, must be a "follower" of Sephora's Twitter account in order for Sponsor to be able to contact the selected winner. (This requirement is only for the purposes of facilitating eligibility verification and prize fulfillment communication and may be discontinued following that process.)
