

**“TAYLOR SWIFT LIVE FROM NYC” TWEETSTAKES  
(SEPHORA / WONDERSTRUCK ENCHANTED SWEEPSTAKES)  
Official Rules**

1. **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES OR TO RECEIVE A PRIZE.** A PURCHASE WILL NOT AFFECT OR IMPROVE THE CHANCES OF WINNING. This sweepstakes (“**Sweepstakes**”) is subject to all applicable laws and regulations. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**
2. **Sponsor:** Sephora USA, Inc., 525 Market Street, 32<sup>nd</sup> Floor, San Francisco, CA 94105 ([www.sephora.com](http://www.sephora.com)). This Sweepstakes is not sponsored, endorsed, or administered by, or associated with, Twitter, Inc.
3. **Eligibility:** Sweepstakes is open only to legal residents of the United States (including Puerto Rico but excluding Rhode Island, Guam and all other U.S. and foreign territories and possessions not otherwise mentioned herein) who are at least 18 years of age and the age of majority in their state or territory of primary residence as of the date of entry and who have a non-protected Twitter account (no purchase or payment is necessary to sign up for a Twitter account). **NOTE:** Due to the way the Twitter service is operated, Sponsor may not receive entries from Twitter users with “protected” updates (i.e., where only people the user has approved can view updates). Sweepstakes is not open to employees, independent contractors, officers, directors, agents or representatives of Sponsor or of Elizabeth Arden, Inc. or of their respective parents, affiliates, subsidiaries, successors and/or assigns, Sponsor’s advertising, promotion and fulfillment agencies, legal advisors, and the immediate family members (mother, father, brother, sister, daughter, son or spouse, regardless of where they live) and persons living in the same household (whether or not related) of any of the foregoing (collectively, “**Sweepstakes Entities**”).
4. **Entry Method:** To enter the Sweepstakes, Tweet your reply to the following question: “What is Taylor Swift’s favorite number?” posted on Sponsor’s Twitter account (@Sephora) (the “Sweepstakes Question”) within three (3) hours of the Sponsor’s posting of the Sweepstakes Question. Sponsor may, at its sole discretion, accept a technically incorrect response or message. To qualify for entry, a Tweet message must be a targeted reply to Sponsor’s Twitter account (i.e., @sephora) using Twitter’s @Reply function and it must include the hashtag #SephoraGiveaway. If an entrant’s Twitter account is set to “protected mode” your updates/responses may not be visible in Sponsor’s @Reply inbox, and may not be received by Sponsor unless entrant has previously consented to permit Sponsor to view entrant’s Twitter updates. @Reply messages not received by Sponsor during the Sweepstakes Period will not be entered into the Sweepstakes.

Only one (1) entry per person will be accepted during the Sweepstakes Period. Subsequent attempts made by the same individual to submit multiple entries by using multiple Twitter accounts or otherwise may be disqualified. Entries generated by a script, computer programs, macro, or other automated means will be disqualified. Entries that are incomplete, lost, late or misdirected, deceptive or otherwise not in compliance with these Official Rules may be disqualified at Sponsor’s sole and absolute discretion. Sponsor is not responsible for late, incomplete, misdirected, delayed, or undelivered entries, including without limitation entries not timely received due to telephone failures, Internet or website failures and disruptions, and ISP problems. Incomplete information may result in disqualification of entry. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the authorized account holder of the email address associated with the Twitter account of the entry, which the entrant will have the obligation to establish. All entries carry an equal chance of winning.
5. **Sweepstakes Period:** The Sweepstakes Period will begin on October 8, 2012 at the time Sephora posts the Sweepstakes Instructions and will last for three hours.
6. **Selection of Winner:** Winner will be selected from all eligible entries received during the Sweepstakes Period (as determined by checking the Sephora @Reply folder for qualified and complete responses to Sponsor updates calling for entries) in a random drawing conducted by Sephora on October 8, 2012 after the end of the Sweepstakes Period. The potential winner will be contacted by Sponsor via a direct message to the potential winner’s Twitter account, and for that reason, must be a “follower” of Sephora’s Twitter account in order for Sponsor to be able to contact the selected winner. (This requirement is only for the purposes of facilitating eligibility verification and prize fulfillment communication and may be discontinued following that process.) If a potential winner forfeits a prize (see Section 9), an alternate winner will be selected from all remaining eligible entries until a winner is determined. The odds of winning depend upon the total number of eligible entries received during the Sweepstakes Period. All decisions of Sponsor are final and binding on all entrants.
7. **Prize:** One (1) winner will be awarded the grand prize with an approximate retail value of \$2,265. The grand prize consists of a pair of passes to see Taylor Swift perform at the Ed Sullivan Theatre in New York City on October 23, 2012, a Taylor Swift Wonderstruck Enchanted Gift Set, and a \$2,000 American Express® gift card.

All other expenses related to acceptance of the grand prize not explicitly listed herein as being part of the grand prize are the responsibility of the grand prize winner, including but not limited to, any travel-related

costs associated with attending the Taylor Swift performance in New York City. Prizes are non-refundable and non-transferable, cannot be combined with any other special offer or promotion, and must be accepted as awarded. Sponsor is not responsible for replacing the American Express® gift card prize if lost, stolen, mutilated or is otherwise rendered unusable due to any act or omission of prize winner or other third party. Redemption and use of American Express® gift card is subject to the terms and conditions thereof. Prizes may not be exchanged for cash value or substituted, except that Sponsor reserves the right in its sole discretion to substitute with either the cash value of the prize, or a prize or prizes of equal or greater value. Applicable federal, state or local taxes and any other costs or expenses associated with the prize are the sole responsibility of the winner. There will be no other prizes. Prize will be awarded, and the American Express® gift card will be delivered to the confirmed winner to a valid U.S. address within [1 week] of winner's return of a signed and completed affidavit of eligibility and liability/publicity release (see Section 9).
